Director Marbury reported that this project was part of the 2020/2021 capital improvement program. Cactus Asphalt had a cooperative job order contract with Pinal County. Their quote for double chip sealing Road 2 North from Peppertree to the end of the road at Bright Star was comparable to previous bids, cheaper than the chip seal portion cost from 2018, and came under the Town's budgeted amount.
